Message from the Chairperson

2021 has been an exceptionally challenging year due to the COVID-19 pandemic and ongoing restrictions. Responding to these challenges, I am happy to report a year of excellent achievements and performance by DESSA. We have continued to adapt our work practices and innovate enabling us to fulfil our vision and mission as set in our social inclusion strategy, 'Enabling Participation and Contribution 2019 – 2022'.

2021 saw the continued implementation of our family support work through the provision of training and advocacy to parents and guardians of disabled children and young people. This work was complemented by the capacity building of family support staff in collaboration with Family Resource Centres and Children & Young People's Services Committees.

Our commitment to partnership was reflected in our ongoing support to the DPO Coalition, an alliance of disabled people's organisations (DPOs), and the establishment of new collaborations, such as the Kildare Inclusion in Schools project (KISp) with Kildare Local Authority and County Kildare Advocacy Network.

The UN Convention on the Rights of Persons with Disabilities continues to be the driving force which frames and guides our work in DESSA. Through our training and advocacy work we have raised awareness of the Convention and supported staff and volunteers within the Community and Voluntary sector to develop capacity in effective disability rights advocacy.

My sincere thanks to our staff, Alice Griffin and Linda Howe for their ongoing work and commitment to DESSA. I would like to acknowledge and thank my colleagues on the Board of DESSA for their dedication and commitment.

On behalf of the Board of DESSA, I would like to thank our funders, the Department of Rural and Community Development and Pobal for their ongoing support and commitment to DESSA. Established in 2001 DESSA is a national community development organisation and is unique in developing disability specific work within a community development context. DESSA is about promoting disability rights in Ireland, creating a society where everyone with lived experience of disability and their families can participate equally as full citizens. We do this by to eliminating barriers to enable disabled people to reach their potential and participate fully in their community. Our work is based on the belief that people who experience disability are individuals with rights, not objects of charity.

DESSA's core remit entails the delivery of direct training, advocacy and information support services to individuals and families with lived experience of disability and to organisations supporting them. DESSA also works to develop the capacity of organisations in the Community & Voluntary sector to create non-disabling communities.

Implementation of all DESSA actions is guided by a set of principles which is concerned with building positive relationships and partnerships between disabled people, their families and their community.

Snapshots of DESSA Work

The DESSA Empowering Parents Programme Empowering families through effective advocacy and capacity building

The goal of DESSA's work in supporting families is to ensure that disabled children and young people receive the support and opportunity to enjoy the same quality life outcomes as their non-disabled peers.

Empowering Parents aims to support parents and guardians to acquire the knowledge and skills to effectively to access rights and entitlements on behalf of their children and to understand and influence policy in relation to service provision.

Training in disability equality, advocacy and policy & law is delivered to groups of locally-based parents and guardians in partnership with civil society organisations including parent-led advocacy groups.

Key Outcomes in 2021

- 50 parent and guardians participated in the Empowering Parents Programme
- 8 partnerships established in the delivery of advocacy support and capacity building to families. This includes collaborations with Dublin South City Partnership; Dublin City Childcare Committee; Children & Young People's Services Committees in Dublin, Donegal and Wexford; the Family Resource Centre National Forum and FRCs nationwide; HSE Disability Services Kildare; Involve Autism; and Kildare Autism Network.

Snapshots of DESSA Work

Kildare Inclusion in Schools Project (KISP) A partnership initiative between CKAN, DESSA and Kildare County Council

The Kildare Inclusion in Schools project seeks to support County Kildare schools to become positive to disability. Disability equality awareness in schools is extremely important because it educates students so they may become better citizens.

This project aims to

- 1. Create positive understanding and awareness of disability and disability equality amongst children and young people.
- 2. Provide students with practical skills in ensuring their schools are accessible to all, with particular reference to physical accessibility and inclusive communications.

Key Outcomes in 2021

- Delivery training to 24 Transition Year (TY) students in Newbridge Holy Family Secondary School as part of the project pilot.
- Completion of 5 access audits in Newbridge town by TY students
- Development of the draft KISP Toolkit and the KISP Train the Trainer programme for project partners.
- Project participation in Kildare Disability Week

Snapshots of DESSA Work

Disability Inclusion and Family Support A Collaboration with Dublin City South Children and Young People's Services Committee

Disability Inclusion and Family Support is a capacity building project which aims to support families experiencing disability by training members of Dublin City South CYPSC working in family support as disability inclusion advocates.

The project entailed consultation with CYPSC members and the design and delivery of tailored training to family support workers. The vision of this project is that competent, informed and skilled family support workers will be able to support families of disabled children in accessing services, supports and opportunities within their local communities and in being included like all other community members.

A key feature of the project entailed educating participants on the UN Convention on the Rights of Persons with Disabilities and its application to supporting disabled children, a named target group within the Convention.

This work is guided by the belief that inclusion doesn't just happen. The realisation of disabled children's rights and entitlements to quality life outcomes requires the support of a competent, informed and confidant workforce.

Key Outcome in 2021

 15 Family Support Workers participated in a 10-session online training programme to develop their competence and skills in supporting parents and guardians of disabled children and young people.
